KILLARNEY-REFLEX LAKES HERITAGE RANGELAND NATURAL AREA

FIRSTLY: In Township 41, Range 1, West of the 4th Meridian:

The north half, legal subdivisions 1 and 8 and the east half of legal subdivision 7 of section 24, the north half and south west quarter of section 31, all that portion of the south east quarter of the said section 31 which lies generally to the north of the northerly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 1609 C.L. and all those portions of the north west quarter of the said section 32 and legal subdivisions 9, 10, 13, 14, 15, 16 and the north halves of legal subdivisions 11 and 12 of section 33, covered and not covered by the waters of the said Killarney Lake.

SAVING AND EXCEPTING:

- (1) Six hundred seventy-two thousandths (0.672) of a hectare (1.66 acres), more or less, out of the south west quarter of the said section 31, two hundred seventy-five thousandths (0.275) of a hectare (0.68 of an acre), more or less, out of the north west quarter of the said section 32 and one and eighty-two thousandths (1.082) hectares (2.67 acres), more or less, out of the north east quarter of the said section 33 required for a surveyed roadway, as shown upon the said plan No. 1609 C.L.
- (2) Four hundred thirty-five thousandths (0.435) of a hectare (1.07 acres), more or less, out of the north east quarter of the said section 33 required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 912 0018.
- (3) Eight hundred thirty-four thousandths (0.834) of a hectare (2.06 acres), more or less, out of the west half of the said section 31 required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 2077 M.C.

SECONDLY: In Township 42, Range 1, West of the 4th Meridian:

The north east quarter of section 1, the north east quarter of section 2, the north east quarter and south west quarter of section 6, section 11, the south east quarter of section 12, the north west quarter of section 14, the north half and south east quarter of section 23, the west half of section 24, section 25, all those portions of sections 4 and 5 and the south west quarter of section 9 covered and not covered by the waters of the said Killarney Lake and all those portions of the north half and south east quarter of section 36 covered and not covered by the waters of Reflex Lakes.

SAVING AND EXCEPTING:

- (1) Eight hundred fifty thousandths (0.850) of a hectare (2.10 acres), more or less, out of the north west quarter of the said section 23 required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office as No. 852 1336.
- (2) One and sixty thousandths (1.060) hectares (2.62 acres), more or less, out of the west half of the said section 11 required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 3605 C.L.
- (3) Three hundred eighty thousandths (0.380) of a hectare (0.94 of an acre), more or less, out of the south east quarter of the said section 11 required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 3929 C.L.
- (4) Nine and eight hundred ninety-one thousandths (9.891) hectares (24.44 acres), more or less, out of the west half of the said section 11 and one and five hundred sixty-seven thousandths (1.567) hectares (3.87 acres), more or less, out of the north west quarter of the said section 14 required for a surveyed roadway, as shown upon the said plan No. 852 0747.
- (5) Four hundred seventeen thousandths (0.417) of a hectare (1.03 acres), more or less, out of the south west quarter of the said section 6 required for a surveyed roadway, as shown upon the said plan No. 2077 M.C.

THIRDLY: In Township 43, Range 1, West of the 4th Meridian:

All those portions of the south west quarter, legal subdivisions 1 and 2, the south half of legal subdivision 7 and the south half and north east quarter of legal subdivision 8 of section 1 and the south half and north east quarter of legal subdivision 1 and the south east quarters of legal subdivisions 2 and 8 of section 2, covered and not covered by the waters of the said Reflex Lakes.

The lands herein described contain two thousand seven hundred thirty-one and sixty-five thousandths (2,731.065) hectares (6,748.37 acres), more or less.
